**Taxes can be paid in person at the Bridgewater Township Hall located at 10990 Clinton Road during office hours every Thursday from 12:00p.m. - 5:00p.m.** You may also pay your taxes at Old National Bank in Clinton, Manchester or Saline. The bank will **not receive** late tax payments. You may also mail your payment or leave your payment in the black drop box located at the Bridgewater Township Hall. You may also pay your tax bill online with a credit card at [www.is.bsasoftware.com](http://www.is.bsasoftware.com). There will be an additional fee of 3% for this service. **Receipts will be returned only upon request.**

Please make checks payable to Bridgewater Township Treasurer. Checks are accepted only as conditional payment. If not honored by the bank, the tax bill will be restored as unpaid in the tax roll without further notice and will be subject to all interest and penalty charges.

**Winter Property Taxes are due on February 14, 2017 at 5:00 p.m.** From February 15th - 28th, 2017 add 1% penalty. After March 1, 2017 they must be paid to the Washtenaw County Treasurer at 200 North Main Street, Suite 200, Ann Arbor, MI 48107. The County Treasurer's office telephone number is (734) 222-6600. **Postmarks will not be accepted.**

**ERRORS OR OMISSIONS**

Please examine your bill carefully to assure accuracy. Failure to receive a tax bill does not waive penalties and/or interest. Compare the legal description with your own record of title and report any errors immediately. If you think there is an error in the description, your homestead exemption or assessed value, please contact the township assessor as soon as possible.
