Public Comment:

- Per Sally Elmiger of Carlisle Wortman
 - Special Land Use (SLU) can revoke SLU if person is not following restrictions, including if not used for a certain period of time.
 - o SLU cannot expire but township can disallow transfer of SLU.
 - o SLU can be updated; can require annual review, if needed.
 - o Can charge for review, can have it as simply or as complex as needed and desired
- Bridgewater does not currently allow for business grow in SLU, unlike neighboring townships.

Old Business:

- Zoning Enabling Act:
 - Action tabled due to lack of information.
- Procedure Check List:
 - Action tabled due to lack of information.
- Fireworks Ordinance:
 - o Change name to 'Explosives Ordinance'.
 - o Fred Lucas suggest drafting two ordinances,
 - Zoning ordinance, minimum acreage (maybe 100), need setback distance from property line, should be in agriculture zone, need poundage per acre. Need a class 'A' driveway for emergency vehicles. Best if in an old gravel pit, there are no abandoned gravel pits in Bridgewater.
 - Police power ordinance should adopt one.
 - o Must allow for explosives and fireworks because there is no ordinance excluding explosives.
 - o This new explosives ordinance would include everyone, even farmers and their own homes.
 - o Judge only said that Enzer must cease selling fireworks.
 - o Enzer never got FS48 from township.
 - o The Enzer issue is now in the hands of the township board.
 - o Hillsdale sheriff was called about their explosions; 2 people killed in 1st explosion, 6 people killed in 2nd explosion, body parts were found ½ mile away, windows broken 1.5 miles away. Foundation of build was all that was left.
 - o Need scientific evidence if differ from distances of ATF.

- o There was a recommendation that the township coordinate with International Fire Code, using property line instead of inhabited building; maybe add in stages.
- O Dave will talk to Fire Department about what fire codes they follow. Can they enforce them? Is there a state level fire code?
- Everyone on the planning commission should think about conditions that should be added to the ordinance.

• Flag Lots:

- o Sally presented research and recommendations on requirements for flag lots.
- o Any variance would have to go before the ZBA.
- o Will need to improve the private road ordinance if change access strips.
- The new ordinance must be abided by for any new splits.
- o Tabled the discussion until next month, Fred Lucas wants to review. Dave will present to township board.
