## 6. Joint Planning Report:

- Mark Roby; Washtenaw County Principal Planner presented future land uses for four townships (Bridgewater, Manchester, Freedom and Sharon (although Sharon Township is not in the consortium) for 20 30 years out.
- Handed out Joint Planning Area regional map and existing land use maps and use descriptions.
- These maps will eventually replace the current Bridgewater Township land use master plan / zoning ordinance and the regional plan will take precedence over the local plan.
- Would like input by April meeting to make sure they meet needs for township and region.
- Want to cluster development around villages and towns.
- There was talk of needing to possibly make another water / sewer system close to Clinton.
- Dave asked if all of growth is in Manchester, do we loose tax base.
- Large residential developments do not pay for themselves.
- Should think about light industrial along Michigan Ave. due to traffic; the problems is no water or sewer
- Should add natural features to map.
- Bridgewater Township will adopt this joint plan as our plan.
- The object of the joint planning is for coordination of efforts.
- Mark Roby described how the joint planning commission came about.
- There will be a master plan to go along with the map.
- Sally suggested that the map be parcel specific.
- If zoned as prime agricultural, it will be harder to zone as residential.
- Should list in the master plan why it was zoned the way it was, for future reference.
- The community will have input into the final plan.
- Mark will come to the planning commission meeting next month.
- Everyone should comment on maps additions, subtractions, changes; Chris will take changes back to SWWCOG.

- Sally suggested getting more maps that show more of the local features of the township. Maybe Bridgewater should update our map and let SWWCOG change their regional map.
- Industry will have to be on US12 since it is the only class 'A' road.
- Sally suggested devoting next meeting to this topic. Sally will bring in additional maps.
- Might need an open public meeting to inform the residents of the pending changes.
- Sally should be included on the e-mail lists.
- Dave will talk to Jolea and board about a special meeting to discuss this.
- Everyone should review the categories and apply those to the Bridgewater map.

  - Dave suggested that sub-committees review this document.
  - For defendable distances, Dave quoted a 'Department of the Army Field Manual FM5-25' for personal safety; Sally suggested using the recommended setback from ATF.
  - Must state why changing to whatever distances are approved.
  - Class B fireworks rated by amount of explosives, approximately 50% of the weight.
  - Dusty and Mark will work on this; Dave will supply a CD with pertinent information.
  - Section 5, Paragraph 1, missing Section 8.201 (Performance Standards). Dave will call Fred about this.

# 10. Flag Lots

- Dave talked with Fred; he said that we could legally do whatever we want.
- Sally referred to the Carlisle/Wortman document regarding flag lots dated 11-FEB-08.
- Dave suggests that shared driveways are allowed with deed restrictions and maintenance agreements and limit the way the houses face easement with front yard setback measured from the easement. This would eliminate the 2 front yard setbacks.
- Changes to zoning ordinance would only affect flag lots. Sally will determine cost to handle looking at the needed changes to zoning ordinance.

#### 12. Private Sewer:

- Two or more homes sharing a common drain field; under 20,000 gallons per day; could be for 6 to 8 houses.
- Need to create our own ordinance, deed restricted, must notify the local government (part of site plan review process).
- Community can maintain, if needed, at owners expense. It can force inspection with certified tech., county inspection once a year; can create a special assessment district to pay for repairs or maintenance.
- Can put on zoning map.
- Local ordinance can be stricter than county ordinance, which is upheld by law.
- Dave will get copies of county ordinance by 15-MAR-08.
- Design ordinance for where and how to limit.
- Laurie supplied ordinance for Ann Arbor township
- Will review findings next month
