A. Crego Peltcs parcel renewal for Stansley Mineral Group (SMR)

- 1. Presentation
 - Chip Tokar gave a brief overview of the parcel under review
 - Renewal of permit for 5 years per ordinance 59
 - 22.3-acre lake, created in sections, will reclaim as agricultural, with possibility of residential development later
- 2. Planning Commission/Consultant Comments
 - Bill DeGroot referenced his review, 30-Dec-11
 - The residential rezoning would be by Crego Peltcs family
 - Bridgewater Township should have all bonds before excavation is started
 - Notices were placed in 29-Mar-12 editions of the Clinton Local and Manchester Enterprise, letters were sent to all residents within 2000' on 23-Mar-12
 - Received a letter from Brighton Analytical stating that oil/grease in sample bottles <u>causing false</u> <u>positives</u>, letter on file
 - All items requested by Bridgewater Township have been provided
- 3. Public Comment
 - Public hearing opened at 7:18
 - Michael Geigerz of 12312 Hogan asked depth of lake; 60 foot; berms will be 8-10 feet from road level
 - Testing of domestic wells annually will continue; new letters will be sent to residents within 2000'

- Excavation will start this year
- Tom Peltcs of 811 Red Mill Tecumseh; complained about his mother not getting letters in regards to the permit
- Asked about current knob; Chip Tokar showed on plan
- Asked about the road; Chip Tokar showed the road on the final plan
- Asked about Chip Tokar having POA to represent SMR; all permits will be signed by SMR
- Letter of credit is \$75,000; to be reviewed annually
- Said his lawyer sent a letter asking that a decision not be made until he has had time to review
- Bill DeGroot reminded all that all information is public, including the lawyers input
- Public hearing closed at 7:33

- Rodney Nanney handed out CDs with the draft copy of the Bridgewater Zoning Ordinance
- Rodney Nanney will e-mail the table of contents
- To prepare for the public hearing; should have copies of the draft zoning ordinance on the township web site, place paper copies in the three public libraries, place announcements in the local papers
- The summary of changes should be published in the announcement for public comment
- Reviewed summary of changes, below are items that members should pay particular attention to while reviewing the draft
- Article 2; eliminating the R2 district eliminated area for mobile home
 - o Rodney recommended reinstating the R2 district specifically for prefab housing
 - o Don't have to have water & sewer since they can install their own
 - o It is in the master plan, which needs to be reviewed
 - o Adult businesses also need to be addressed; need to identify where this could be without a SLU
- Article 4; medical marijuana; ordinance says that anything against federal or state law is illegal in Bridgewater so recommend just removing all mention of it
- Article 5; nature preserves, should review including definition; limited business use language; fire protection; high volume wells
- Ron Smith will follow up with Grant Howard in regards to his findings on nature preserves
- Article 6; accessory structures in front yard, must still meet set back requirements
- Article 8; site plan reviews; site planner as inspectors
- Article 11; exterior lighting; dark skies lighting
- Article 16; nonconforming uses; expansion and alterations
- Article 19; definitions
- Ron Smith asked about the supervisor granting permission in case of emergency; Laurie Fromhart said that they could only do this for SMR because of the consent judgment
- We will continue the review at the next regular meeting, 14-May-12
