8. Explosives Ordinance

- Jolea Mull, Dave Faust and Fred Lucas meet with Enzer's lawyer on Thursday 8-APR-08
- Enzer wants BF-48 signed
- Enzer is in court for criminal charges
- Two options
 - Move explosives out of Bridgewater
 - O Consent judgment (non-binding) (about a dozen items were discussed, some of which include):
 - Must relocate to a Class A road
 - Must obey ATF setbacks to property lines
 - Must allow free reign to inspect the facility at will
- Henry did not have time to work on blast radiuses
- Henry expressed concern over Enzer's deceit and not performing what he promises without forcing him
- Some of Enzer's neighbors are complaining about semi traffic
- Court said he has to cease commercial operations
- Henry asked who can perform an inspection
- Dave reviewed ATF suggested distances from explosives to property line
- All listed poundage is in black powder equivalences

- There is no performance standard, per say
- Mark discussed "Storage of Hazardous Materials" from Fred Lucas
 - o Fuel storage tanks needs to be reviewed
 - o 1.1b Fireworks, page 2; does not give much description; needs to be in plainer English and with more detail
 - o Emissions level cannot be tested
 - Should not have items in ordinance that cannot enforce
- The local fire departments should adopt International Fire Code
- Henry will work on the "Storage of Hazardous Materials" with Mark and bring results in to the May meeting; will talk to fire department
- Dave talked to fire marshal who said he didn't know who would enforce the International Fire Code
- Neither Clinton nor Manchester fire departments have adopted the International Fire Code

9. Flag Lots

- Other townships do up to 4 splits per driveway; with maintenance agreement and deed restriction
- Dave suggest 3 splits per shared drive with maintenance agreement and deed restriction; any more would require a private road
- There is a driveway ordinance already; not currently enforced; section 1229
- Sally said that a driveway ordinance can be enforced
- Sally said that health, safety and welfare of the citizens is the responsibility of the township so driveways should be able to give access to fire and police
- Discussed access for fire equipment
- Shared driveways are an exception to the planning ordinance
- The shared driveway maintenance agreement should be written to share cost equally; maintenance work approved by majority vote
- Sally said should update 1208; A3
- Current cluster housing road is a Class A road minus the pavement; none of the current gravel roads would meet the cluster housing road standards
- Currently need a minimum of a 2 acres per lot
- Should adjust the cluster housing ordinance to encourage cluster development
- New changes to ordinance should state that 40' driveway easement; drive must be centered in the easement; maintenance agreement and deed restriction; House must face the easement, on front lot the house can face the main road; front yard setback will be the yard facing the easement; a turnout area shall be provided for every 500' of driveway; 4 house maximum per shared driveway; reference section 1229 for current driveway standards
- Must write up the changes to review with the board, before public review
- Henry will type out section 1208 with changes listed above to present to township board on 1-MAY-08 to ask for comments; Henry will e-mail document, reps will review and comments before the board meeting

10. Ordinance Review:

- Bridgewater Township's Zoning Ordinance needs to be updated
- Dave pointed out that Sharon Township just updated their ordinance; Bridgewater should compare theirs with Sharon Townships for opportunities
- Special land uses need to be reviewed and enforced
