

- Dave Horney commented that there are three categories; public right-of-way, interaction of other properties, general considerations of what will be allowed or not allowed
- Restrictions can be placed on the conditional use if done before approval
 - Laurie Fromhart said that the township should place the limits on now, those are:
 - 1. Four parking spaces
 - 2. 15 visitors per day
 - 3. Use restricted to church membership only
 - 4. Locked gate at entrance
 - 5. No permanent structures
 - 6. No camping
 - 7. No fires
 - 8. No dock or boat launch
 - 9. No boardwalks
 - 10. No lighting
 - 11. No public use
 - 12. Port-o-potty must be secured, winterized
 - 13. Trash must be carried out
 - 14. Property would not be removed from the tax roles without a permanent structure
 - 15. Use of alcohol
 - 16. Condition of driveway permit
 - 17. Signage requirements for identification of property line
 - 18. Mark the property every 100'
- Susan McGarry said that there are no plans for electricity
- Dave Horney recommended dawn to dusk hours
- Mark Iwanicki talked about signage and locked gates work for the honest
- Wes Cowden commented on what he found when he walked the property, there is little they can do to be bad neighbors
- Bill DeGroot commented that once a person submits a request for a SLU, the planning commissioners have the right to do due diligence and walk the property
- Susan McGarry said she talked to the owners of the property and they agreed to the removal of the trees for the second time, it was recommended that Susan get permission in writing
